You are accepting the responsibility of keeping us informed of address changes, email changes and any change to your email address on your PayPal account. Sales are tallied during the first week of the month for the previous month. A minimum of \$5 commission will generate a payment by the end of that month. **Legalese:**

When appropriate in context, all references herein to the singular shall include the plural and to the masculine gender shall include the feminine.

This Agreement sets forth the entire agreement of the two parties and shall be construed in accordance with the laws of the State of Tennessee with respect to contracts executed and to be performed therein and shall be binding upon parties their respective successors, heirs and assigns in the event of litigation. In the event that any provision of this Agreement shall, for any reason, be held invalid or unenforceable, all other provisions herein shall continue in full force and effect. This agreement may not be modified or amended except by written agreement signed by both parties.

All notices given hereunder by either party to the other (excluding accounting statements) shall be transmitted in writing by US Registered or Certified Mail, Return Receipt Requested to the parties' addresses set forth in this document.

The term "Gross Receipts" shall mean the gross sums actually received by the Publisher or its agent in the US (or credited against an outstanding advance previously paid by the Publisher to the extent the Composer did not receive this share of said advance pursuant hereto), reduced by collection fees actually charged by any agent, sub-publisher or organization, or legal fees, court fees, accounting fees or other direct costs incurred by the Publisher in the collection of such sums. Gross receipts shall not be deemed to include any portion of any advance payments guarantee payments or minimum royalty payments, which Publisher may receive in connection with any sub-publishing agreement, collection agreement, licensing agreement or other agreement with respect to the composition.

Publisher shall have the right to collect (or authorize others to collect) on behalf of the Composer, the "writer's share" of all Monies payable with regard to the composition pursuant to the Audio Home Recording Act, 17 United States Code Section 1002, et seq. ("AHRA Monies") and Composer hereby assigns said AHRA Monies to Publisher. Writer's share of AHRA Monies shall be distributed by Publishers to Composer in accordance with the terms of this agreement.
